## Solar panel subsidies in North America

Which states offer solar incentives?

Arizona, Hawaii, Massachusetts, New Mexico, New York, South Carolina and Utah offer personal tax credits to encourage solar installations. Other states, like Tennessee, West Virginia and Oklahoma, don't have any residential solar panel incentives at all. NOTE: Solar program statuses often change with new laws or funding.

Which states offer solar rebates & tax credits?

Solar rebates, tax credits, sales tax exemptions and other incentives vary significantly from state to state. Arizona, Hawaii, Massachusetts, New Mexico, New York, South Carolina and Utah offer personal tax credits to encourage solar installations.

Do electric utilities offer incentives for solar metering?

While the federal solar tax credit is the only widely available residential solar incentive from the federal government, many states have incentives available to homeowners who adopt solar. Within those states, some electric utilities offer incentives as well. Electric utilities are also responsible for Net Metering.

Can you get a solar tax credit if you install a battery?

The IRA also included standalone or retrofitted energy storage projects, so batteries added to an existing system would qualify for the 30% tax credit as well.
