## Tax rates for selling solar panels

Are solar panels taxable?

If the solar panels are fitted to a private residence, this income will be tax free, but businesses and landlords that rent out the accommodation need to be aware that their payment will be seen as taxable income, subject to income tax or corporation tax as appropriate.

Do you pay sales tax on solar?

Solar sales tax exemptions reduce the upfront cost of going solar. If you live in a state with sales tax, you could pay between 2.9% and 9.5% sales tax on the cost of a solar installation. 17 states exempt that purchase from sales tax, and five other states don't have sales tax at all.

How much would a solar tax cost per year?

The CPUC's latest solar tax proposal would cost users between \$300 and \$600 per year. It's important to note that the less electricity you use, the more you would pay in solar taxes. Karinna Gonzalez, who works for a clean energy non-profit organization in San Diego, added solar panels back in December when she heard of CPUC's first solar tax proposal for all new solar customers.

Do contractors have to pay tax on solar energy installations?

Because contractors are retailers of the fixtures, tax is due either on the retail selling price or the cost price of the fixtures depending on the type of contract.
